# UMBRELLAS ON BALCONIES

We reported in the October newsletter that an umbrella fell from a balcony in the tower and broke a glass canopy when it landed. In light of this occurrence, and in an on-going effort to ensure all residents are complying with the Governing Documents, we'd like to remind you that the CC&Rs prohibit umbrellas from being on balconies.

Specifically, Section 7.5.9, Awnings, Etc. states: "No awnings, ornamental screens, screen doors, sunshades, or umbrellas of any nature shall be erected or maintained on or around any portion of any structure or elsewhere within the Project except those that are installed in accordance with the original construction of the Project or as are authorized and approved by the Architectural Committee."

If you currently have an umbrella on your balcony, please remove it immediately to avoid the risk of damage if it is to fall from your balcony, and to come into compliance with the CC&Rs.

The association is also in the middle of window washing, and dripping water from units above can ruin the freshly cleaned glass on your neighbors' windows.

The holiday season is here! Please be reminded that Thanksgiving and the day after are treated as holidays—no vendor access is allowed these two days.
